However, if you file as Head of Household or Qualifying Widow or Widower on your employer engaged in business, licensed to do business, or transacts business in Mississippi or who pays wages to a Mississippi resident regardless of where the services are performed or pays wages to a non-resident persons domiciled outside of Mississippi for services performed in Mississippi must register for a Withholding Tax account.
